## A BILL

To authorize funds to carry out the purposes of the Appalachian Regional Development Act of 1965, as amended, and title V of the Public Works and Economic Development Act of 1965, as amended.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 TITLE I—APPALACHIAN REGIONAL DEVELOP-  
2 MENT ACT OF 1969

3 SEC. 101. This title may be cited as the “Appalachian  
4 Regional Development Act Amendments of 1969”.

5 SEC. 102. The Appalachian Regional Development Act  
6 of 1965, as amended, is amended as follows:

7 (1) The last sentence of subsection (b) of section 105  
8 is amended to read as follows: “To carry out this section  
9 there is hereby authorized to be appropriated to the Com-  
10 mission, to be available until expended, not to exceed \$1,-  
11 780,000 for the two-fiscal-year period ending June 30, 1971.  
12 Not to exceed \$400,000 of such authorization shall be avail-  
13 able for the expenses of the Federal cochairman, his alter-  
14 nate, and his staff.”.

15 (2) Subsection (b) of section 205 is amended by  
16 striking out “and 1969,” and inserting in lieu thereof  
17 “1969, 1970, and 1971,”.

18 (3) The first sentence of subsection (c) of section  
19 214 is amended by striking out “December 31, 1967,” and  
20 inserting in lieu thereof “December 31, 1969,”.

21 (4) Section 401 is amended by striking out the period  
22 at the end thereof and inserting in lieu thereof a comma and  
23 the following: “and not to exceed \$225,000,000 for the two-  
24 fiscal-year period ending June 30, 1971, to carry out this  
25 Act.”.
